PURPOSE OF THE CAREER NARRATIVE

- 1. Contextualizing Your Work:** It provides reviewers with a comprehensive understanding of your career trajectory, including your scholarly and professional development.
- 2. Highlighting Achievements:** It allows you to showcase the milestones and accomplishments that have defined your career, particularly those that demonstrate your potential for significant contributions to your field.

KEY ELEMENTS TO INCLUDE

- **Challenges and Turning Points:** Consider including any challenges or significant turning points that have influenced your career path. This can provide depth to your narrative and show resilience, adaptability, and growth.
- **Current Focus and Relevance to the Proposed Project:** Clearly connect your past work to the project you are proposing for the fellowship. Demonstrate how the fellowship will enable you to build on your previous work or explore new directions.
- **Future Aspirations and Goals:** Outline your future goals and how they align with your career trajectory. Emphasize how the fellowship will help you achieve these goals and contribute to your long-term impact in your field.
- **Personal Voice and Authenticity:** Use a narrative style that feels authentic to you. The fellowship values originality, so let your unique voice come through in your writing.

GENERAL WRITING TIPS

- While you want to provide a comprehensive overview, avoid overwhelming the reader with too many details. Focus on the most significant points that demonstrate your growth and potential.
- Go beyond listing accomplishments—explain their significance, both to your development and to your field.
- Your narrative should not only inform but also engage. Make it a story that reviewers will find compelling and memorable.
- Given the importance of this component, be sure to revise multiple times and consider seeking feedback from colleagues who are familiar with your work.



SAMPLE OUTLINE FOR A CAREER NARRATIVE

Use the following guide to help you craft a Career Narrative that weaves together your achievements, intellectual growth, scholarly impact, and future aspirations into a coherent story. It should be personal yet professional, showcasing both your scholarly rigor and passion for your work. Each section should flow logically to create a compelling narrative that clearly demonstrates why you are an ideal candidate. Note: This is just a general framework, not a strict template. Moreover, the content does not need to be presented in standalone sections; instead, weave it into a cohesive narrative.

Opening Paragraph: Establishing Who You Are: Start with a paragraph that immediately communicates your scholarly identity, current standing, and the caliber that aligns with what the fellowship seeks to support. Mention any innovative courses you have developed or how your research informs your teaching. Note any meaningful community or public engagement efforts related to your work (e.g., public lectures, community-based projects, or policy advising). Highlight your active engagement in academic communities—serving on editorial boards, organizing conferences or symposia, and participating in collaborative research networks.

Significance of the Fellowship: Clearly articulate how receiving the fellowship fits into your career trajectory.
